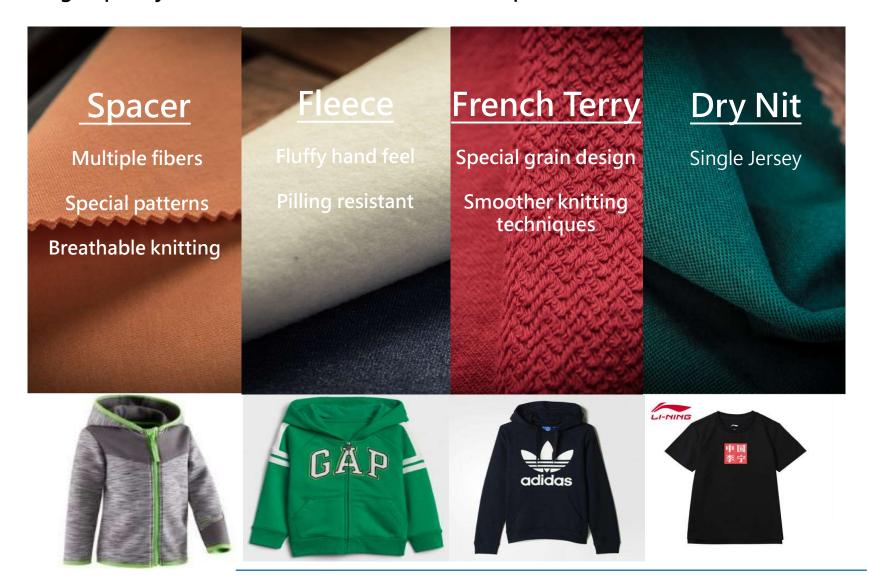




- International customers with brand value : International famous brand, adidas, PUMA, GAP, LI NING etc.





